Surveyor's Corner

Gregg- I just want you to know that I particularly enjoyed your March 2004 discussion of the AZ PLSS initial point. I wanted to ask you why the Gila and Salt River Meridian is variously referred to as different things. Sometimes I see it GR&SRBM, and, sometimes something else. What is the proper designation?

This question is an old favorite - in the AZ Surveying community - which is generally discussed after having one too many beers.

The following was a very similar question dating back from 1999:

"The lender won't fund the project unless the description includes 'Base and,' in Gila and Salt River Base and Meridian (sic). The surveyor has to explain why this is incorrect, but the lender is adamant because "all the other surveyors write it that way."

And, from March, 2002:

"I am with the Arizona State Land Dept. and I have been using Gila and Salt River Meridian in my descriptions since I have been here (7 years).

All records and maps we receive from BLM reads G&SRM.

Last week an Attorney insisted we use Gila and Salt River Base and Meridian, in the description of a sale. Can anyone tell me which is correct and why???? Our Title and Contract People are insisting that I use Base in the descriptions."

Well, being a (public) land survey *trivia* buff, I couldn't resist an attempt to add to the knowledge, (and, probably, the controversy), surrounding this age old question, (which is right up there with the chicken and the egg.)

In the BLM (Bureau of Land Management) Manual of Surveying Instructions, 1973, Chapter III, The System of Rectangular Surveys, page 59, section 3-3 it states:

"In accordance with the foregoing legal requirements, the public lands are surveyed under the method called the system of rectangular surveys, which embraces the following procedure:"

- (1) The establishment of independent initial points, each to serve as an origin for surveys to be extended in separated localities.
- (2) The survey of principal meridians AND BASE LINES, originating at the initial point.
(CAPITALIZATION is EMPHASIS added for this article.)

On page 60 of the manual there is a table entitled: Meridians AND BASE LINES of the United States Rectangular Surveys (CAPITALIZATION EMPHASIS added.)

The first column is entitled: MERIDIAN under which is listed, in alphabetical order " Gila and Salt River".

Well so far, it still seems up in the air - could be either G&SRM or G&SRB&M, or even G&SRM&B !

Next source: A HISTORY OF THE RECTANGULAR SURVEY SYSTEM, Volume One, by C. Albert White, original BLM published version, early 1980s.

Page 164:

"Clark reported on May 24, 1865, that he had adopted this monument, as the initial point for the Gila and Salt River Meridian in Arizona..." (quoted from the official GLO report.) **Hmmm, - - - Sounds like a vote for G&SRM.**

Next source: a published paper, from a 1939 conference, by Sherman C. Fiske, Engineer of Public Surveys (GLO) on the HISTORY OF PUBLIC LAND SURVEYING IN ARIZONA, it says:

"The General Land Office on December 15, 1866, entered into a contract with deputy surveyor Wm. H. Pierce, through John A. Clark, surveyor general at Santa Fe, for the survey in Arizona of 96 miles of the Principal Meridian, 46 miles of Base Line, 84 miles of the First Standard Parallel North and various township boundaries initiated there from, for an aggregate sum not exceeding \$7,500.00 In the instructions issued for those surveys the monuments set at the junction of the Gila and Salt Rivers in 1851, and mentioned on the preceding pages as being one the U.S. - Mexico original boundary monuments, was designated as the Initial Monument for the Arizona Public Land Surveys, the Principal Meridian to be called the Gila and Salt River Meridian, and the Base Line to be called the Gila and Salt River Base Line."

Wow! how about G&SRM -and- G&SRB ??

Further on Fiske states:

"This monument has since controlled all of the public land surveys in Arizona, except for a period in the Colorado River Indian Reservation, where a special Base and Meridian controlled the survey of part of the townships therein, but which was later abandoned and all such townships resurveyed, using the Gila and Salt River Base Line and Meridian for control;..."

Interesting! Maybe we should include: "G&SRBL&M" !!!???!!!

A (very) brief review of microfiche GLO/BLM plats illustrates that there is no real hard and fast rule for the title. The vast majority use Gila & Salt River Meridian... However, I was easily able to locate examples from T1N/R1W in the 1919 era, whose title included the phrase Gila & Salt River Base & Meridian. (G&SRB&M)

Well.... what to think? What to do?

I think that this little survey trivia question has probably been around since they started PLSS in AZ. When I took the 1976 Arizona land boundary surveying examination, one of the 'fill-in' questions was what is the "correct" title when reference the subject meridian and baseline? The only address accepted by P.B. was G&SRM (period! end of discussion!)

However, I am personally at a loss to find that definitive document which MANDATES the use of G&SRM to the exclusion of all other variations and forms, such as G&SRM&B, G&SRBL&M, G&SRB&M or even G&SRB, -- not to mention G&SRM and G&SRB as a separate coupling.

Now we could all get together and pass a legislative fiat that herein after it will officially known as, and only accepted as G&SRM....

Yeah right! - in our dreams!

Maybe we can be a little more tolerance because as noted above even GLO used G&SRB&M on their office plat maps.

Maybe if you are an extreme stickler for details you would dictate that any reference on a modern survey drawing, and/or written description, should reference EXACTLY whatever is shown on the appropriate/applicable GLO/BLM official plat map.

(It would be my luck to have to reference two difference plat maps with difference meridian/base descriptors!)

In the future, maybe we should have a more tolerant attitude on the issue of G&SRM versus G&SRB&M, or is it G&SRM&B, or maybe G&SRBL&M? What would you do? What are you using?
